Sub: **Regarding amendment in Delhi Ladli Scheme Rules 2008 and extension of time limit**

Sir/Madam,

1) Please find enclosed a copy of Notification No.8(1) FAS/GCPR/DSW/06-07/8529-543 dated 6-8-08 vide which Delhi Ladli Scheme Rules 2008(hereinafter referred to as the Rules) have been amended. The amendments provide for relaxed procedures for girls studying in class I, VI, IX and XII who do not have birth certificate issued by Registrar MCD/NDMC, being otherwise eligible under the scheme, for the academic session 2008-09.

2) It is to inform further that the time limit for filing applications under Delhi Ladli Scheme by school going girls has been further extended upto **31-10-2008** to enable the eligible girls to take advantage of the relaxed procedure, pursuant to the captioned amendments.

3) These changes may please be brought to the notice of all the Heads of the schools in your jurisdiction so that all eligible girls avail of financial assistance under the Scheme.

4) In pursuance of the amendments to Rule 5 and Rule 6 of the Rules, also enclosed is the format of certificate to be issued by the Heads of recognized schools to eligible girls studying in class VI, IX and XII who were born in Delhi but do not have birth certificate issued by Registrar, MCD/NDMC.
