मौजूदा रिक्तियों तथा निकट भविष्य में उत्पन्न होने वाली रिक्तियों को भरने के लिए, किशोर न्याय अधिनियम, 2015 की धारा 27 और नियम 15 (3) के अनुसार बाल कल्याण समिति के 03 अध्यक्षों और 17 सदस्यों के, धारा 4 और नियम 4, 5 के अनुसार किशोर न्याय बोर्ड के 10 सामाजिक कार्यकर्ता सदस्यों का राष्ट्रीय राजधानी क्षेत्र दिल्ली में किशोर न्याय अधिनियम और किशोर न्याय मॉडल नियम, 2016 के अंतर्गत उपरोक्त मानद पदों के लिए ऑनलाइन आवेदन आमंत्रित किए जाते हैं।



Department of Women and Child Development published an advertisement on dated 27.07.2021 to fill up vacancies in Child Welfare Committees and Juvenile Justice Boards, against which applications were received. In due course of time more vacancies have arisen. The Department is also in the process of constituting new Child Welfare Committee and new Juvenile Justice Boards.

Thus, Online Applications are invited for the Honorary posts of 03 Chairpersons and 17 Members of Child Welfare Committee as per Section 27 of Juvenile Justice Act, 2015 and Rules 15 (3) and 10 Member Social Workers of Juvenile Justice Boards as per Section 4 of Juvenile Justice Act and Rule 4, 5 & Rule 88 of Juvenile Justice Model Rules, 2016 in NCT of Delhi, to fill up existing vacancies and those arising in near future.

The applications shall be accepted w.e.f 27.12.2021 to 10.01.2022. After scrutiny the list of shortlisted candidates with relevant experience suited for the said positions shall be displayed on the website of the Department with schedule of interview. Applicants are advised to refer to the Department's website [www.wcddel.in](http://www.wcddel.in) for detailed terms of reference/ eligibility criteria and refer to link as given in Department's website for applying online. Candidates are also advised to see the Department's Website/ Notice Board on regular basis for any other update in this regard while the process is on.

**Term of reference for Member Social Worker of Juvenile  
Justice Boards**

1. The candidates applying for the honorary post of Member Social Worker should be above 35 years of age as on last date of application. Social Worker Members shall have at least seven years of experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law
2. The Member Social Worker of the Board will be paid honorarium of Rs. 3500/- per sitting or as decided by the Government.
3. The duties of Member Social Worker call for full time sitting from 10:00 Am to 5:00 PM on all working days.
4. A Member Social Worker of a Board shall be eligible for appointment of maximum two terms, which shall not be continuous.
5. In addition to this, the State Government has the power to terminate the services of any Member Social Worker of juvenile Justice Board at any point of time in accordance with the provisions of the Juvenile Justice (Care & Protection of Children) Act, 2015 & Rules thereunder.
6. Member Social Worker selected by the Selection Committee should meet the criteria as envisaged in Sub-Rule 5 of Rule 88 Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
7. An undertaking will have to be furnished by each shortlisted candidates as per format attached.

## Term of reference for Chairpersons/Members of Child Welfare Committees

1. The candidates applying for the honorary post of Chairperson/Members of the Child Welfare Committee should be above 35 years of age as on last date of application. A member of the Committee unless such person has been actively involved in health, education or welfare activities pertaining to children for atleast seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human development
2. The Chairperson/ Member of the Committee will be paid honorarium of Rs. 3500/- per sitting or as decided by the Government.
3. The duties of Child Welfare Committee call for full time sitting from 10:00 Am to 5:00 PM on all working days..
4. A Chairperson and Members of a Committee shall be eligible for appointment of maximum two terms, which shall not be continuous.
5. In addition to this the State Government has the power to terminate the services of any Member of CWC at any point of time in accordance with the provisions of the Juvenile Justice (Care & Protection of Children) Act, 2015 & Rules thereunder.
6. Chairperson/Members selected by the Selection Committee should meet the criteria as envisaged in Sub-Rule 5 of Rule 88 Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
7. An undertaking will have to be furnished by each shortlisted candidates as per format attached.
