Sub: Applications are invited for Honorary work as Chairperson and Members of Child Welfare Committee (CWC) and Member Social Worker of Juvenile Justice Board constituted under the Juvenile Justice (Care & Protection of Children) Act, 2000 for facilitating services in relation to children in need of care and protection and juvenile in conflict with law.

Child Welfare Committee shall consist of a Chairperson and four Members and Juvenile Justice Board consist of a Principle Magistrate and two Member Social Workers.

Post I - Child Welfare Committee :- A person to be selected as Chairperson/ Member of the Committee shall have either of the following qualification in addition to **minimum seven years** experience in their respective fields, namely:

- (a) A post graduate degree in Social Work, Psychology, Child development, Education, Sociology, Law, Criminology;
- (b) A teacher, doctor or a social worker who has been involved in work concerning children with specific reference to children in need of Care & Protection;

Post II – Juvenile Justice Board :- A person to be selected as Member Social Worker of the Board shall have either of the following qualification in addition to **minimum seven years** experience in their respective fields, namely:

- a) A post graduate degree in Social Work, Health, Psychology, Child development, Education, Sociology, Law, Criminology or any other social science discipline and;
- b) He/she has been actively involved and engaged in planning, implementing and administering measures related to child welfare.

Terms & Conditions:

1. The Chairperson or Member of the Committee/Board shall be a person not less than 35 years of age and not more than 65 years of age.
2. The Chairperson/Member/Member Social Worker will be paid honorarium of Rs. 1250/- per sitting. The duties of CWC/JJB call for full time sitting from 10.00 AM to 5.00 PM for 5 days a week.
3. The tenure of the CWC/JJB shall be for a period of three years and the tenure of Members shall also be three years from the date of their appointment.
4. In addition to this the State Government has the power to terminate the services of any Member of CWC/JJB at any point of time in accordance with the provisions of the Juvenile Justice (Care & Protection of Children) Act, 2000.
5. No person shall be considered for Selection as a Chairperson or Member of the Committee/Board, if he/she
 - a) Has a previous conviction record;
 - b) Has been involved in any immoral act or in an act of child abuse or employment of child labour;
 - c) Is holding such full-time occupation that may not allow him to give necessary time and attention to the work of the Committee/Board as per the aforesaid Act and Delhi Juvenile Justice (Care & Protection of Children) Rules, 2009;
 - d) Does not fulfill the qualification and experience prescribed in the Act and the rules made thereunder.

Procedure of applying:

Interested persons may kindly submit their application in the following performa specifying duration and experience in chronological order along with supportive documents to the Director, Women & Child Development, Government of NCT of Delhi at 1, Canning Lane, K. G. Marg, New Delhi-110001 so as to reach him latest by 5.00 pm on 10.09.2013.
