**Subject- Invitation for submission of paintings by children for the journal's cover page.**

The bi-annual journal "*Children First: Journal on Children's Lives*" by Delhi Commission for Protection of Child Rights (DCPCR) aims to deepen the discourse by providing a platform to all people engaging with the rights of children in varied capacities regardless of their nationality and socio-economic backgrounds.

The first issue of the journal covers various issues related to children, including education, health and nutrition, protection, disability issues, adoption, child labour, violence and abuse, and adolescent issues, in light of COVID-19 pandemic.

However, to add the perspective of children in making of the journal, the Commission invites paintings/sketches/drawings from children in child care institutions, schools across the country and individuals on the theme, "***Impact of COVID-19 pandemic on lives of children***".

Selected paintings by experts will be used on the cover page or any other page of the journal, along with the name, age and institution of the child.

To participate, the candidate must be below 18 years of age.

Children can use drawing paper, art paper or any other type of white paper of A4/A3 size for painting.

The painting could be ink, water colour, oil colour or any other medium. Children can submit their scanned paintings or high resolution picture of the painting in .JPEG format at <childrenfirst.jocl@gmail.com> . The subject of the mail should be "Painting for DCPCR Journal ".

Name, age, contact number and institution (if applicable) of the candidate must be mentioned clearly in the mail and the painting file name must be in the name of the candidate for ex- amitsingh.jpeg

By submitting, the children agree that DCPCR can use it in its journal or any other publication with due acknowledgement to the child artist.

Deadline to submit the paintings is July 1, 2021.
