**EXPRESSION OF INTEREST FOR AWARENESS GENERATION, SUPPORT &  
PROTECTION FOR CHILDREN IN VULNERABLE SITUATIONS INCLUDING STREET  
CHILDREN**

Expression of Interest is invited for empanelment of Non-Governmental Organisations/ Civil Society Organisations willing and prepared to undertake community interventions aiming to identify and wean out the vulnerable children including children adversely affected of COVID-19 pandemic and bring them to the safety net following the protocols of the Juvenile Justice (Care & Protection of Children) Act, 2015.

The NGOs/ CSOs to be empaneled with the Department of Women & Child Development, GNCTD would be assigned following activities based on the format to be filled by the NGO with reference to geographical area, no of children for which interventions needed.

- 1) Campaign for street children using print/ visual means of IEC/street plays & through other innovative means of information dissemination for public awareness.
- 2) Identifying and profiling of vulnerable children
- 3) Resource mapping and matching the needs.
- 4) Mentoring and fostering child care through protection and participation
- 5) Creating accessibility to medical and mental health care
- 6) Conduct family visits, outreach children to connect with support system
- 7) Facilitate access to vital supplies and COVID protective equipment i.e. face masks, sanitisers, hand wash/soaps.
- 8) Educate on COVID appropriate behaviour, personal hygiene and sanitation
- 9) Assistance for continuation of education, special education, higher education, skill development
- 10) Follow up and mentoring for educational accomplishments and career guidance.
- 11) Maintaining digital records to track and monitor the child's well-being & linkage to schemes/services.
- 12) Conduct 'Bal Samvad' with street children for identifying issues of concern, enabling them to help themselves with developing problem solving approaches. Also identifying and nurturing 'Bal-Mitras' as agents of change;
- 13) Creating awareness and participation on the themes of cleanliness and hygiene;
- 14) Any other institutional, non-institutional or alternative family based intervention

Interested NGOs/ CSOs/VOs duly registered under any law for welfare activities, may submit the letter of intent supported by documents including organisation's profile, areas of operation, funding support, proposals of campaign and community intervention to identify, educate and support to reduce vulnerability of children initially for the current F.Y. which may be extended to one year subject to performance and impact and outcome of the initial interventions.

Application in prescribed format to be submitted within 10 days from the date of publication of the EOI i.e. 22.07.2021. Details on SAMPARC i.e. A Sustainable Approach for Multi-faceted Progress Aimed at Reclaiming Childhood- which gives full context of the policy & the Convergence Plan of Action and the prescribed format are uploaded on the Department's website <http://www.wcddel.in/>.

Expressions of Interest from NGOs/VOs are invited both on a pro-bono as well as financial support basis. Proposal must include details of financial implications/approximate budget with clear mention of the proposed activities/services and the cost involved therein.
