



GIA CASE OF THE NGO 'BHARTIYA PARIVARDHAN SANSTHAN'

The GIA Committee also discussed and examined the matter of release of grant-in-aid for the year 2008-09 and 2009-10 to the NGO 'Bhartiya Parivardhan Sansthan' under the scheme for Prevention of Alcoholism and Substance of (Drug) Abuse in view of the letter vide No. P-11013/45-F/2007-DP-I dated 29.11.10, received from the Ministry of Social Justice & Empowerment, Govt. of India.

This letter from the Ministry asked the State Govt. of Delhi the following points:-

1. The State Government has not mentioned whether the proposals of the organization for release of grant-in-aid for 2008-09 and 2009-10 are recommended;
2. Whether the audited observation made by Directorate of Audit, Local Fund Accounts, Govt. of Delhi is acceptable by the State Government; and
3. Whether the proposal is fit for further release of grant-in-aid in spite of continued Court hearing.


On the matter, the GIA Committee reaffirmed its stand of recommending the GIA to the NGO for the year 2008-09, in continuation of its letter dated 14.6.10 sent in this regard to the Ministry. It decided to apprise the Ministry that the Deptt. of Social Welfare and Women & Child Development have already awarded different projects/ work order to the NGO related to 'Drug De-addiction centre in Beggar Home Complex, Lampur' and to 'Setting up of Child Specific Drug De Addiction centre at Observation Home for Boys-II, Kingsway Camp, Delhi.

COMMON OBSERVATIONS FOR RECOMMENDED CASES:


The GIA Committee observed that the above listed cases are recommended to Ministry of Social Justice & Empowerment, Govt. of India with the following common observations:-

1. In view of the fact that the Ministry of Social Justice & Empowerment, Govt. of India has decided State-wise notional allocation under different GIA schemes. The amount of GIA for the recommended cases may be decided as per the proportion of actual grant disbursed last year.

2. The quantum amount of GIA may be decided by the Recommendation Committee at Govt. of India after looking into the utilization of the previous grants.
3. The sanction be based strictly in accordance with norms of the scheme as applicable to the respective case.



- It should be well managed stable organisation with facilities, resources and personnel to undertake welfare work.
- It should not be run for profit to any individual or body of individuals.
- It should have a properly constituted Managing Body with its powers/duties and responsibilities clearly defined and laid down in a written Constitution.
- Its services should be open to all without distinction of caste, religion or language.
- It should be possible to relate the number of years of useful work the organization has done with the quantum of grant that should be given.
- Projects not covered by any of the existing schemes of the Department of Women and Child Development including the Central Social Welfare Board (CSWB).

- Assistance under this Scheme will be given to Organisations working with women: for their social uplift and betterment, for carrying out education work for the prevention of atrocities on women by propaganda, publicity and research work.
- It should ordinarily have existed for a period of two years. In special circumstances, however this prescription can be waived.
- It should be recognised, aided or approved by a least one State Government.
- It should have facilities, resources and experience for undertaking the programme.


