**Sub : Applications are invited for Honorary work as Member Social Worker for Juvenile Justice Board (JJB) constituted under the Juvenile Justice (Care & Protection of Children) Act, 2015 for facilitating children in conflict with law. Juvenile Justice Board shall consist of a Pr. Magistrate and two Member Social Workers, of whom at least one shall be a woman forming a bench.**

1. A person to be selected as Member Social Worker of the Board shall have at least seven years experience of working with children in the field of Education, Health or Welfare activities or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.

**Terms & Conditions :**

2. The Member Social Worker of the Board shall be a person not less than 35 years and not more than 65 years of age at the time of appointment.
3. The Member Social Worker will be paid honorarium of Rs. 3500/- per sitting. The Board shall meet on all 6 working days from 10.00 A.M. to 5.00 P.M.
4. A Social Worker being a member of the Board shall be eligible for appointment for a maximum of two terms, which shall not be continuous.
5. The appointment of any member of the Board may be terminated after holding an inquiry by the State Government, if he-
  - (i) has been found guilty of misuse of power vested under this Act; or
  - (ii) fails to attend the proceedings of the Board consecutively for three months without any valid reason; or
  - (iii) fails to attend less than three-fourths of the sittings in a year; or
  - (iv) becomes ineligible under sub-section (4) during his term as a member.
6. No person shall be considered for Selection as a Member Social Worker of the Board, if he-
  - (i) has any past record of violation of human rights or child rights;
  - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
  - (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
  - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.

Child Welfare Committee shall consist of a Chairperson and four Members of whom at least one shall be a Woman.

**Child Welfare Committee :-** A person to be selected as Chairperson/ Member of the Committee shall have either of the following qualification in addition to **minimum seven years** experience of working with children and actively involved in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer.

**Terms & Conditions:**

1. The Chairperson or Member of the Committee shall be above the age of 35 years of age.
2. The Chairperson/Member will be paid honorarium of Rs. 3500/- per sitting.
3. The duties of CWC call for full time sitting from 10.00 AM to 5.00 PM for 5/6 days a week.
4. A Member of a Committee shall be eligible for appointment of maximum two terms, which shall not be continuous.
5. In addition to this the State Government has the power to terminate the services of any Member of CWC at any point of time in accordance with the provisions of the Juvenile Justice (Care & Protection of Children) Act, 2015 & Rules thereunder.
6. No member shall be selected if he/she;
  - (i) be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board or the Committee as per the Act and rules;
  - (ii) be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or Committee or have any other conflict of interest.
  - (iii) hold any office in any political party during his/her tenure, or
  - (iv) be insolvent.
  - (v) Has been involved in any immoral act or in an act of child abuse or employment of child labour;
